

SCHOLARSHIP PROGRAM

The Program

Johns Eastern Company's Scholarship Program offers financial assistance for college or vocational schools to dependents of employees who have been employed by Johns Eastern Company for at least three years. Dependents of deceased, disabled or retired employees also are eligible.

The award is \$500.00 for each year of full-time study. Scholarships are awarded based on academic achievement. Awards may be renewed for up to an additional three years on the basis of satisfactory performance.

Eligibility

Employees must meet the following criteria for their children to be eligible:

- The employee must be an active, full-time employee of Johns Eastern Company.
- The employee must have been employed by Johns Eastern Company for at least three (3) years at the time the scholarship is awarded.

Students must meet the following qualifications in order to be eligible:

- The student must be 23 years of age or younger and a dependent of a Johns Eastern Company employee.
- The student must be a high school senior or graduate. Newly eligible students may currently be enrolled at a college or vocational school.
- The student must plan to be enrolled or must currently be enrolled in a full-time undergraduate course of study at an accredited two- to four-year college, university or vocational technical school. Students must enroll in the college of their choice no later than the fall of the year in which the award is given.
- The student must have a high school grade point average of 3.0 or better. For automatic renewal (up to three years), the student must maintain a grade point average of 2.5.
